Project Overview:

Boca Raton Synagogue (BRS) needs security improvement measures to protect the facility and improve known vulnerabilities, especially with the elevated risk of anti-Semitic hate crime attacks. These measures include the installation of blast, shock, and impact resistant windows to best protect the synagogue's members, patrons, and schoolchildren from harm.

Project Goals:

The objective of this project is to reduce the catastrophic levels of destruction and death upon an active shooter or intruder entering the campus. New blast, shock, and impact resistant windows are needed in the school wing to protect the high school students on site each weekday and the small children there each Sabbath and holiday, as the current windows are unfortified and not impact resistant, so they do not prevent forced entry and would shatter and cause injury in case of an attack.

Scope of Work:

- Installation of blast/shock/impact resistant windows in the school wing.

Current Roadblocks and Barriers to Success:

We are aware that delays in shipments can take up to 4 months and we will be monitoring this closely throughout the process.

Evaluation Metrics and Criteria:

- Capacity and experience: Bidders will be evaluated based upon the respondent's overall capacity and experience relevant to the work in this RFP and demonstrated ability to complete the scope of practice by the project completion date.
- Method of approach: Bidders will be evaluated based on their planned approach to the project, including ability to address current and future challenges and to work with BRS staff.
- Budget and resource allocation: Bidders will be evaluated based on their planned budget and resource allocation, with an emphasis on using funds wisely.
- The bidder that is selected to complete this project will have a clear and appropriate outline in mind for the project to be completed in a timely manner.
